COVID-19 and school admission appeals

The Department for Education (DfE) has published new legislation, which took account of the coronavirus (COVID-19) outbreak and its impact on carrying out admission appeals in the usual way. This legislation, which covers existing school appeals came into force on 24 April 2020, and will remain in force until 30 September 2022.

The DfE have indicated that the new regulations will:

- Continue to give parents the right to appeal to any school which has refused their child a place
- Disapply the requirement that appeals panels must be held in person and instead give flexibility for panel hearings to take place in other forms, including by telephone, video conference or through a paper-based appeal where all parties can make representations in writing

Instruction

- If you wish to appeal against the decision of your child not being offered a place at Archbishop Tenison's CE High School, you should contact the Admissions Officer at the school to request an appeal pack.
- Completed appeals forms should be returned to the Appeals Administrator, at the school address **by midday on Friday 6 May 2022 at the latest.**
- The School has appointed an Admission Appeals Clerk who is entirely independent of the school. She will appoint an Independent Appeal Panel to hear any appeals that are lodged.
- School statements and appellants' appeal paperwork will be sent to all parties (appellants, the school, panel members and clerk to the panel) at least 7 working days prior to the appeal hearings.
- Having received the papers, the appellants and the School have the opportunity to present any additional evidence. Any additional evidence must be received no later than 5pm on the day preceding 3 clear working days before the appeal hearings. If received after that time, the additional evidence may not be considered by the Appeal Panel.

Appeal timetable for mid-term applications (excluding Sixth Form)

- An appeal will be heard within 30 school days of an appeal having been lodged. School statements and appellants appeal forms will be sent to all parties (appellants, the school, panel members and the clerk to the panel) at least 7 working days prior to the appeal hearing. Having received the papers, the appellants and the school have the opportunity to present any additional evidence. Any additional evidence must be received no later than 5pm on the day preceding 3 clear working days before the appeal hearing. If received after that time, the additional evidence may not be considered by the Appeal Panel.
